II. Panel Discussion: Food Access for Seniors This topic arose out of the discussions of the CalFresh Alliance FSC work group.

Panelists:

SLO Village is a local non-profit that helps seniors to age in place, live in their own homes, and stay connected to the community through a volunteer network. It is a self-run community where seniors contribute to the solutions.

SSI recipients (including seniors) may be eligible for CalFresh benefits without reducing their SSI benefits starting June 1, 2019. Previously they have been ineligible. The lowest benefit amount is \$15 per month per person, which can be saved up month-to-month to save for a big purchase (e.g., thanksgiving). The highest amount is \$192 per month per person. For people with limited mobility, an authorized representatives can act on their behalf, or they can sign up via the phone or online. \$1 in CalFresh transforms = \$1.72 into the local economy.

Meals that Connect prepares and delivers around 156,000 free, hot meals to over 1,500 senior residents each year throughout the County (~500 meals/day). Hot meals are delivered daily Monday through Friday with frozen meals for weekends and holidays. 60% of deliveries are delivered at homes, and 40% are delivered at community sites for social dining. The organization is run by paid staff and over 300 volunteers. The meals are free to recipients but cost ~\$10 per meal for food and labor.

These organizations can interface. A senior can receive meals from Meals that Connect, receive CalFresh benefits, and be connected to other services through SLO Village.

Identified Challenges:

- SLO Village Funding, finding volunteers.
- DSS People's hesitance to receive government assistance
- Meals that Connect Data for grants
- General Seniors' hesitation to accept help even though all seniors eventually face poverty because the cost of living grows to exceed income, except for the most wealthy. Cutting back on food to budget affects nutrition and health.
