- Roots of Change is catalyst group, and they announced that they will be stepping out of that role as soon as they have their own stability and funding.

- Legislative Report Card. CA FPC produced the first one in 2013. Have created one for 2014. Set up for disseminating information to the public about how elected officials vote for food system related bills.

  participation has decreased.
- Admin Committee proposes that we adopt the Paradox of Plenty report as a guiding document for 2015.
  - o The report has food system actions that are aligned with our mission.

- o Karen and Stephanie worked on this last summer.
- Activity: Write past, current, and future projects that relate to the Paradox of Plenty goals written around the room, including your organization and those you know of (Activity results attached).
  - O Comments: People were amazed by the accomplishments and what is already happening in community. There is a lot of overlap between projects. Good to review the different goals of the report. All the goals are so connected, that a domino effect can take place. Valuable if we can capture the little parts that aren't working well within the food system. Lots of dreams- if we can connect with the right people, we can innovate and solve these problems.
  - o It would really help us if we have reportable success stories.

- Internal Resources of FSC (Cannot take any actions where we do not have the appropriate and required resources):
  - Members with aligned missions
  - o Staff time 5.5 hours
  - o Geographic region- Ag community, local sourcing. fisherfolk, etc.
  - o Network of the members.
- The group brainstormed activities for the next year (attached), discussed resources needed, and willingness to take action.
- 2015 Actions:
  - o EBT- Stephanie Teaford will lead work group and Linda McClure will participate, Advocacy & Outreach Working Group.
  - o School gardens- Teresa Lees with Advocacy & Outreach Working Group
  - o Event (networking event)- Adria Arko will lead work group and Jen Miller will participate
  - o Food Hub- Central Coast Grown is leading this work group
  - o Community Cafes-Stacey Hunt is leading this work group

Other items: Status of North County EBT- EBT is no longer at North County farmers' market and it is unclear when or if it will return.
